# **Before Driving**

- Preparing the vehicle
- Adopting a safe driving position

# **Basic Manoeuvres**

- Driving in a straight line
- Mastering the steering wheel
  - Positioning the hands correctly on the steering wheel
  - Handling the steering wheel correctly
- Controlling the vehicle's steering
- Controlling and maintaining the vehicle's speed
- Controlling the vehicle's acceleration
- Controlling braking and bringing the vehicle to a stop
- Exiting the vehicle

Scanning the road environmentt



# AT ALL TIMES, THE LEARNER DRIVER MUST:

    - · Avoids focusing on any one object
    - · Keeps his or her eyes moving
    - · Looks far ahead
    - Increases his or her field of vision (sweeping view)

### **Evaluates**

- Evaluates the vehicle's condition
- Evaluates the road environment

- Adopts a safe driving position
- Manoeuvres the vehicle safely
- Exits the vehicle safely

### MANOEUVRES AND BEHAVIOURS

### **Manoeuvres**

- Driving forward out of a driveway onto a public road
- Pulling out from the side of the road
- · Parking on the side of the road

### Intersections

- Crossing an intersection
  - Locating stop signs
  - Identifying who has right of way
- Turning at an intersection with or without stop signs

# Stopping

- Slowing down and bringing the vehicle to a stop
- Stopping at an intersection

# Backing up

Controlling the vehicle when backing up

### Vision

- Scanning the road environment
  - Visual scanning
  - Checking rear-view mirrors
  - Doing shoulder checks (blind spots)
- Locating stop signs

# THE INSTRUCTOR MUST ENSURE THAT THE LEARNER DRIVER:

# **Observes**

- Scans the road environment
  - Checks rear-view mirrors
  - Visual scanning
    - Avoids focusing on any one object
    - · Keeps his or her eyes moving
    - · Looks far ahead
    - Increases his or her field of vision (sweeping view)
  - Does shoulder checks (blind spots)
- Locates stop signs

### **Evaluates**

- Evaluates who has right of way
- Anticipates traffic light changes

# **Acts**

- Uses turn signal lights (correctly and at the right time) to communicate his or her intentions to others
- Ensures he or she can be seen by other road users
- Positions the vehicle in the turning lane
- Adopts safe, cooperative and responsible behaviour behind the wheel

# **MANOEUVRES AND BEHAVIOURS**

### **Manoeuvres**

- Driving forward into a parking space
- Perfecting control of the vehicle when backing up

# Intersections

- Turning at intersections with traffic lights
  - Turning right
  - Turning left
  - Turning right at a red light
- Perfecting turns at intersections with or without stop signs
  - Turning onto a one-way street
  - Turning onto a road with a median or other divider, etc.

### Action

Yielding the right of way

# THE INSTRUCTOR MUST ENSURE THAT THE LEARNER DRIVER:

### **Observes**

- Explores the road environment by visual scanning, checking rear-view mirrors and doing shoulder checks (blind spots)
- Increases his or her field of vision
- Detects places where there are likely to be vulnerable road users (with the instructor's help)
  - School zones, parks, hospitals, etc.
  - Pedestrian crosswalks
- Detects the presence of vulnerable users on the road network
  - Mid-way through the session, ask the learner driver to name, while continuing to drive, the last vulnerable users he or she saw on the road

### **Evaluates**

- Interprets the risks detected
- Foresees an emergency exit/Plans for a way out in an emergency

- Positions the vehicle in the appropriate lane before, during and after turning at an intersection
- Adapts his or her driving to the situations encountered (e.g. traffic, types of users present, weather and road conditions)
  - Adjusts driving speed
  - Increases the safety margins around the vehicle (in front, behind, on the sides)
  - Lets others pass, etc.
- Adopts safe, cooperative and responsible behaviour behind the wheel

**Duration:** 1 hour **Route:** Easy, urban area

Traffic: Light

# THINGS TO EMPHASIZE

Vulnerable users: pedestrians, cyclists, motorcyclists, moped and scooter operators, etc. Familiarization with urban driving

# **MANOEUVRES AND BEHAVIOURS**

# **Actions**

- Driving in the appropriate lanes
- Changing lanes in different driving situations
- Maintaining the safety margins around the vehicle (in front, behind, on the sides)
- Perfecting turns at intersections

# THE INSTRUCTOR MUST ENSURE THAT THE LEARNER DRIVER:

- Detects potential risks (with the instructor's help) with a view to independent driving

# **Evaluates**

- Anticipates when traffic will slow down and stop, and the mandatory stops of certain vehicles at level crossings (school buses and city buses)
  - Slows down, brakes, increases safety margins, yields the right of way, etc.
- Detects risks in the road environment (distinguishes between risks and normal situations)
- Searches for solutions to avoid or reduce risks

- Adapts his or her driving to the situations encountered (e.g. traffic, other users present, weather and road conditions, etc.)
  - Adjusts driving speed
  - Increases the safety margins around the vehicle
  - Changes lanes
  - Lets others pass, etc.
- Is learning to handle unforeseen events
- Adopts safe, cooperative and responsible behaviour behind the wheel

**Traffic:** Light to medium-heavy (varied speed limits)

Potential or real risks in rural areas: animals, speed variation, etc.

**Emergency vehicles**

- Recognizes safe, cooperative and responsible behaviour in other road users
- Explores the road environment by visual scanning, checking rear-view mirrors and doing shoulder checks (blind spots)
- Detects potential and real risks

# **Evaluates**

- Evaluates the possibilities
- Evaluates the level of risk
- Searches for solutions to avoid or reduce risks

- Adapts his or her driving to the situations encountered (e.g. traffic, other road users present, weather and road conditions, etc.)
  - Adjusts driving speed
  - Increases safety margins around the vehicle (in front, behind, on the sides)
  - Changes lanes
  - Lets others pass, etc.
- Adopts safe, cooperative and responsible behaviour behind the wheel

# INDEPENDENT DRIVING

In the next five minutes, ask the learner driver to perform certain manoeuvres on his or her own (without the instructor's help).

- Turning
  - The learner driver determines where and how to make the turn.
  - The learner driver makes the turn on his or her own.
- Stopping at an intersection
  - The learner driver stops far enough behind the vehicle ahead to fully see the vehicle's rear tires.
  - The learner driver stops where prescribed by the Highway Safety Code (before the stop line or the pedestrian crosswalk).
- The learner driver must make sure that:
  - The manoeuvres are permitted;
  - The manoeuvres are safe;
  - The manoeuvres can be performed without interfering with other road users (e.g. another user is not cut off; other users have the room and time they require);
  - The turn signal lights and brake lights are used appropriately to indicate his or her intentions, etc.

In subsequent sessions, the learner should perform these manoeuvres on his or her own.

# **Observes**

- Explores the road environment by visual scanning, checking rear-view mirrors and doing shoulder checks (blind spots)
- Recognizes the influence of other road users' actions on himself or herself
- Detects potential and real risks
- Perceives potential conflicts

# **Evaluates**

- Evaluates the possibilities
- Evaluates the level of risk
- Searches for solutions to avoid or reduce risks

- Adapts his or her driving to the situations encountered (e.g. traffic, other road users present, weather and road conditions, etc.)
  - Adjusts driving speed
  - Increases safety margins around the vehicle (in front, behind, on the sides)
  - Changes lanes
  - Lets others pass, etc.
- Adopts safe, cooperative and responsible behaviour behind the wheel
- Avoids potential conflicts
  - Avoids nervous and provocative behaviours

# INDEPENDENT DRIVING

- In the next five minutes, ask the learner driver to change lanes on his or her own (without the instructor's help).
- · Changing lanes:
  - The learner driver determines when and how to change lanes.
  - The learner driver changes lanes on his or her own.
- The learner driver must make sure that:
  - The manoeuvre is permitted.
  - The manoeuvre is safe.
  - The manoeuvre can be performed without interfering with other road users (e.g. another user is not cut off; other users have the room and time they require).
- The learner driver must properly use the turn signal lights to indicate his or her intentions, etc.

In subsequent sessions, the learner driver should perform this manoeuvre on his or her own.

# THE INSTRUCTOR MUST ENSURE THAT THE LEARNER DRIVER:

 Is able to perform all of the manoeuvres and adopt the behavours learned to date, in a semi-guided to independent manner.

In the next five minutes, ask the learner driver to perform a parking manoeuvre on his or her own (without the instructor's help).

- Parking manoeuvre
  - The learner driver looks for a space in a parking lot and parks the car without help.
  - The learner driver looks for a place to park the car on a street in a residential neighbourhood, and parks the car without help.

In subsequent sessions, the learner driver should perform these manoeuvres on his or her own.

# Semi-Guided to Independent Driving

**Duration:** 1 hour

Route: Average to difficult
Traffic: Light to medium-heavy

### THINGS TO EMPHASIZE

Awareness that consuming alcohol, drugs and medication is an at-risk behaviour Distractions

Safe, cooperative and responsible behaviour

Mid-way through the session, ask the learner driver to turn on the fan or heat while driving.

 Check whether the learner driver is able to perform driving-related tasks (e.g. turning on the fan or heat) without it affecting his or her driving (e.g. an abrupt change in course).

# **MANOEUVRES AND BEHAVIOURS**

- Perfecting independent driving (manoeuvres and behaviours)
- Eliminating distractions or reducing them to a minimum

# THE INSTRUCTOR MUST ENSURE THAT THE LEARNER DRIVER:

### **Observes**

- Explores the road environment by visual scanning, checking rear-view mirrors and doing shoulder checks (blind spots)
- Indentifies the distractions inside and outside the vehicle
- Detects potential risks

### **Evaluates**

Searches for solutions to avoid or reduce risks

- Adapts his or her driving to the situations encountered (e.g. traffic, other road users present, weather and road conditions, etc.)
  - Adapts driving speed
  - Increases safety margins around the vehicle (in front, behind, on the sides)
  - Changes lanes
  - Lets others pass, etc.
- Adopts safe, cooperative and responsible behaviour behind the wheel
- Concentrates on driving
- Eliminates distractions or reduces them to a minimum

# INDEPENDENT DRIVING

- Give the learner driver directions on how to get to the chosen destination, as you would for a tourist, for example.
- The learner driver must reach the destination by following the directions.
- Check whether the learner driver is able to get somewhere on his or her own. During the debriefing, review the following concepts:
  - Is the learner driver able to comply with the *Highway Safety Code* and follow road signs and traffic signals while finding his or her way on the road?
  - Does the learner driver pay special attention to other road users, particularly vulnerable users, or is the learner driver too focused on following the directions?
  - Is the learner driver self-assured while driving, or does the learner driver seem to hesitate about which way to go?

# Being the Driver

Traffic: Very heavy

# THINGS TO EMPHASIZE

In-car sessions 12 and 13 are combined or as part of a single two-hour session. The two learner drivers in the vehicle each take turns being the observer and the driver.

# MANOEUVRES AND BEHAVIOURS

 Perfecting driving (manoeuvres and behaviours) with a view to being independent on the road network

# INDEPENDENT DRIVING

- Before heading out, inform the learner driver that he or she will be driving on his or her own.
  - The learner driver must drive to a specific destination (e.g city hall, municipal library) with a minimum of input from the instructor

Route: Average to difficult

Traffic: Very heavy

# THINGS TO EMPHASIZE

In-car sessions 12 and 13 are combined or as part of a single two-hour session. The two learner drivers in the vehicle each take turns being the observer and the driver.

# THE OBSERVER'S JOB

The observer

# Analyzes the learner driver's driving

- Identifies the learner driver's strengths and what he or she needs to work on
- Justifies his or her observations
- Proposes solutions to help the learner driver drive more safely, cooperatively and responsibly

# Observes the road environment

- Recognizes the potential and real risks of the road environment
- Identifies what the learner driver must do given these risks
- Finds solutions for safe, cooperative and responsible driving

# **Eco-Driving**

duration: 1 hour
Route: Varied
Traffic: Varied

# THINGS TO EMPHASIZE

- Eco-driving manoeuvres and principles
- Principles of eco-driving
  - Planning the trip: thinking of other means of transportation, leaving ample time to make the trip, etc.
  - Use of air conditioning
  - Vehicle loads (e.g. baggage carrier)
  - Vehicle maintenance
  - Checking of tires (condition and pressure)
  - Choice of route (types of roads, presence of stop signs or traffic lights, etc.)
  - Idling time
  - Etc.

# **MANOEUVRES AND BEHAVIOURS**

# Speed (eco-driving manoeuvres)

- Accelerating and decelerating gradually
- Avoiding sudden braking
- Driving more slowly between the vehicle's stops (e.g. between two stop signs)
- Maintaining a stable, legal speed adapted to the road environment

# Anticipation (eco-driving manoeuvres)

- · Anticipating changes in traffic speed
  - Looking far ahead
  - Reacting rapidly, but not abruptly, to slowing traffic up ahead
- Anticipating mandatory stops
- · Anticipating traffic light changes
- Maintaining safety margins all around the vehicle
- Perfecting driving

# THE INSTRUCTOR MUST ENSURE THAT THE LEARNER DRIVER:

# **Observes**

- Explores the road environment by visual scanning, checking rear-view mirrors and doing shoulder checks (blind spots)
- Detects potential risks

# **Evaluates**

Searches for solutions to avoid or reduce risks

- Adapts his or her driving to the situations encountered (e.g. traffic, other road users present, weather and road conditions, etc.)
  - Adapts driving speed
  - Increases safety margins around the vehicle (in front, behind, on the sides)
  - Changes lanes
  - Lets others pass, etc.
- Adopts safe, cooperative and responsible behaviour behind the wheel

### INDEPENDENT DRIVING

• Before heading out, tell the learner driver that he or she will be doing part of the driving on his or her own (without the instructor's help).

# **Guided driving segment of the session**

- Ask the learner driver to drive for a few kilometres. Choose a route where you will come across buildings or places that stand out on the trip (e.g. school, shopping centre, hospital, city hall).
- Ask the learner driver to identify landmarks that can be used during the independent driving part of the trip (Reference: In-Car Session 5).

# Independent driving segment of the session

- At some point during the drive, tell the learner driver that he or she will be driving independently during the next part of the trip.
- Ask the learner driver to take you to a specific place (other than the driving school) that you came across during the guided-driving part of the trip.
- Check whether the learner driver is able to find his or her way without help. Review these concepts during the debriefing:
  - Is the learner driver able to comply with the *Highway Safety Code* and follow road signs and traffic signals while finding his or her way on the road?
  - Is the learner driver focused solely on his or her landmarks, or does the learner also pay attention to other road users, particularly vulnerable users?
  - Is the learner driver self-assured while driving, or does the learner driver seem to hesitate about which way to go?



# AT ALL TIMES, THE LEARNER DRIVER MUST:

- Comply with the Highway Safety Code and the Criminal Code
- Obey road signs and traffic signals
- Apply the duty of care principle
- Cooperate with road users, particularly vulnerable users (sharing the road)
- Adopt safe, cooperative and responsible behaviour behind the wheel
- Make decisions in keeping with road safety

- Searches for solutions to avoid or reduce risks

### Acts

- Adapts his or her driving to the situations encountered (e.g. traffic, other road users present, weather and road conditions, etc.)
  - Adapts driving speed
  - Increases safety margins around the vehicle (in front, behind, on the sides)
  - Changes lanes
- Makes multiple decisions quickly
- Adopts safe, cooperative and responsible behaviour behind the wheel

Night driving

- Pay close attention to other road users
- Stay alert
- Drive at a safe speed

# **MANOEUVRES AND BEHAVIOURS**

# **Strategies**

- Adopting strategies specific to night driving
  - Reducing driving speed
  - Increasing the safety margin between you and the vehicle ahead
  - Keeping the windshield clean and in good condition
  - Maintaining proper lighting
  - Avoiding staring at the headlights of other vehicles
  - Avoiding blinding other drivers
  - Adjusting rearview mirrors to the night driving position
- Using low beams and high beams properly

# THE INSTRUCTOR MUST ENSURE THAT THE LEARNER DRIVER

# **Observes**

- Adapts visual exploration techniques to night driving
  - Checks the rear-view mirrors
  - Visual scanning
    - Avoids focusing on any one object
    - Keeps his or her eyes moving
    - Looks far ahead
    - Increases his or her field of vision
    - Maintains peripheral vision
  - Does shoulder checks (blind spots)
- Pays close attention to the road environment
- Avoids being blinded by the headlights of other vehicles

# Winter Driving

# THINGS TO EMPHASIZE

When the situation presents itself, use this sheet in conjunction with an in-car session provided for in the learner driver train Risks of winter driving: icy or snowy roads, reduced visibility, etc.

Risks related to icy roads: losing control, getting stuck, etc.

- Stay alert
- Drive at a safe speed

- Adopting strategies specific to winter driving
  - Reducing driving speed
  - Increasing the safety margin between you and the vehicle ahead
  - Handling the vehicle smoothly, especially the steering wheel and brake pedal
  - Scanning the road attentively and more often
  - Using the lights of the vehicles ahead as a guide, if necessary
  - Keeping the windshield wipers in good condition
  - Looking straight ahead and planning manoeuvres
  - Using the low beams if it is snowing

    - · Keeps his or her eyes moving

- Pays close attention to the road environment

  - Using the lights of other vehicles ahead as a guide, if necessary
  - Keeping windshield wipers in good condition
  - Looking straight ahead and planning manoeuvres
